QUESTION 1: WAS THE END CONSCRIPTION CAMPAIGN (ECC) SUCCESSFUL IN MOBILISING AGAINST THE APARTHEID GOVERNMENT IN THE 1980s?

- 1.1.2 Explain the concept *conscription* in the context of the apartheid government's military policy. (1 x 2) (2)
- 1.1.3 Name any FOUR white groups in the source that were attracted to the End Conscription Campaign. (4 x 1) (4)
- 1.1.4 Why do you think the ECC initiated a series of media campaigns aimed at raising public consciousness regarding the role of the military? (1 x 2) (2)
- 1.1.5 Comment on the significance of the large number of people who attended the 'one public meeting marking the end of the fast in Cape Town' in 1985. (1 x 2) (2)

1.2 Read Source 1B.

- 1.2.1 What, according to the source, was publicly declared by the 771 men during the launch of the national register of conscientious objectors? (1 x 2) (2)
- 1.2.2 Why do you think the apartheid government used emergency regulations to prevent various press conferences from reporting on the ECC's national register launch? (1 x 2) (2)
- 1.2.3 In the context of the ECC, comment on the implication of Chris de Villiers statement, '... we are not prepared to defend apartheid.' (2 x 2) (4)
- 1.2.4 Define the term *referendum* in your own words. (1 x 2) (2)

- 1.4 Refer to Sources 1B and 1C. Explain how the evidence in Source 1B supports the information in Source 1C regarding the ECC's protest campaigns against the apartheid government's military conscription policy. (2 x 2) (4)
- 1.5 Use Source 1D.
- 1.5.1 Quote TWO amendments from the source that were made to the Defence Act in 1983. (2 x 1) (2)
- 1.5.2 Explain what is meant by the statement 'the draconian (harsh) measures in fact had the opposite effect,' regarding the amendment to the Defence Act in 1983. (1 x 2) (2)
- 1.5.3 What evidence, according to the source, indicates that the ECC members were subjected to extensive state repression? Give THREE responses. (3 x 1) (3)
- 1.5.4 Comment on why a historian would find this source reliable when studying the reaction of the apartheid government towards the ECC. (2 x 2) (4)
- 1.6 Using the information in the relevant sources and your own knowledge, write a paragraph of about EIGHT lines (about 80 words) explaining whether the ECC was successful in mobilising against the apartheid government in the 1980s. (8)

- 2.1.3 Why do you think Dr Wouter Basson refused to apply for amnesty? (1 x 2) (2)
- 2.1.4 List any FOUR findings in the source that the Truth and Reconciliation Commission found/uncovered about Project Coast. (4 x 1) (4)
- 2.1.5 Comment on the implication of the statement, '... it (the TRC) found that the programme (CBW) would not have been possible without some level of international co-operation and support'. (1 x 2) (2)
- 2.2 Read Source 2B.
- 2.2.1 What position in the South African Council of Churches did Reverend Frank Chikane hold when he was poisoned in 1989? (1 x 1) (1)
- 2.2.2 Define the term *anti-apartheid campaigner* in your own words. (1 x 2) (2)
- 2.2.3 Comment on the significance of Dr Schalk Van Rensburg's testimony before the TRC amnesty hearings regarding Reverend Frank Chikane's poisoning. (1 x 2) (2)
- 2.2.4 Explain the usefulness of this source to a historian researching how the South African government used chemical and biological warfare to murder anti-apartheid activists. (2 x 2) (4)

- 2.3.1 Explain the meaning of Dr W Basson's words, 'I **SWEAR** I NEVER VIOLATED MY **OATH!**', regarding his activities as head of Project Coast. (2 x 2) (4)
- 2.3.2 Comment on the significance of the human skulls and a bottle with poison depicted in the cartoon in the context of Dr Basson's activities. (2 x 2) (4)
- 2.4 Study Source 2D.
- 2.4.1 Who, according to the source, propped (supported) up the CBW programme? Give any THREE responses. (3 x 1) (3)
- 2.4.2 Name any THREE projects of the CBW programme, as found in the TRC report. (3 x 1) (3)
- 2.4.3 Comment on why the apartheid government resorted to the use of chemicals and drugs against its enemies. (1 x 2) (2)
- 2.4.4 Explain the implication of the statement, '... Project Coast pursued "substances to reduce the fertility and virility (sexual drive) of people" '. (1 x 2) (2)
- 2.5 Refer to Sources 2C and 2D. Explain how the information in Source 2C supports the evidence in Source 2D regarding how the Project Coast violated the rights of the ordinary South African citizens. (2 x 2) (4)
- 2.6 Using the information in the relevant sources and your own knowledge, write a paragraph of about EIGHT lines (about 80 words) explaining whether the Truth and Reconciliation Commission succeeded in exposing the activities of the apartheid government's secret Chemical and Biological Warfare project in the 1980s. - 3.1.3 Comment on what the World Bank implied by 'South Africa remains a dual economy with one of the highest inequality rates in the world'. (2 x 2) (4)
- 3.1.4 Define the term *inequality* in your own words. (1 x 2) (2)
- 3.1.5 What, according to the source, was South Africa's Gini income in 2008? (1 x 1) (1)

3.2 Use Source 3B.

- 3.2.1 State any THREE pillars in the source that South Africa's membership to BRICS is based on. (3 x 1) (3)
- 3.2.2 What do you think is implied by the Zambian economist, Ms Dambisa Moyo's article, titled 'Global Slowdown: Africa's Chance to Stand Up and Shine', regarding Africa's representation in BRICS? (2 x 2) (4)
- 3.2.3 Explain the limitations of this source for a researcher studying the role that South Africa plays in strengthening BRICS as a global economy. (2 x 2) (4)

- 3.5.3 Explain why China's GDP increased from 7,3 trillion in 2011 to 17,458 trillion in 2022. (1 x 2) (2)
